If the dividend recommended by the Directors is approved by members at the Annual General Meeting, it will be paid to Shareholders whose names appear in the Company's Register of members at the close of business on Friday 2nd May 2014. Shareholders who have completed the e-dividend Mandate Form will receive a direct credit of the dividend to their bank accounts on Monday 26th May 2014, while dividend warrants of Shareholders who have not completed the e-dividend Mandate Form will be posted by Thursday the 29th day May, 2014.
